

Meet Zeta Member - Wynona Dye



Wynona Dye was born in North Carolina and went to elementary schools in both Eastern and Western North Carolina before moving to Tennessee as a sophomore in high school. She received a B. S. in Education and an M.S. in English Education from the University of Tennessee. She taught English for nearly 25 years at Holston High School and then 8 more at Gibbs High School, both in Knox County. She worked as a state evaluator for the Career Ladder program for two years. During some summers Wynona attended Foxfire I and II seminars and a Governor's School of Writing. She was a member of the first Knoxville Leadership Education class.

Wynona became a member of Delta Kappa Gamma in 1990. She served on the Social and the Telephone Committees before becoming Second Vice-President and then President of Zeta from 1998 to 2000. She served as Chairman of the Rules, Legislation, and Scholarship and Awards Committees. For Xi State Wynona has served on the Finance Committee, member and Chairman of the Membership Committee, the Awards Committee, and the Achievement Award Committee three times. She served on the board of the Vision Foundation for one term and then was a member of the Personnel Committee for one term. She has attended many Xi State conventions at Sewanee and at least seven international conventions. She attended Leadership and Advanced Leadership Seminars and was awarded the Order of the Rose in 2011. She also served as Area Director 2001 – 2003.

Since retirement Wynona, in addition to attending Zeta meetings, has helped in her church office, joined the bell choir of her church, graduated from the Citizen's Police Academy, and enjoyed her six grandchildren and now three great grandchildren. She also enjoys her P.E.O. Sisterhood meetings. Her hobbies are reading, quilting, crocheting, and traveling.

Legislative Report

Tennessee has seen legislation recently that affects schools in light of the Covid-19 pandemic. Governor Lee ordered schools to remain closed until April 24. In light of the nearly two months of instructional time that has been disrupted this spring, the legislature passed Public Chapter Number 652 which cancels TNReady testing as well as teacher evaluations for this school year. In addition, seniors are not required to pass a civics test for graduation this year, and the 11th grade proficiency test (ACT or SAT) is not required. The bill also ensures that LEAs would not lose state funds due to the suspension of school this year. The State Board of Education was authorized to promulgate emergency rules to address issues caused by school closures and the bill requires the Commissioner of Education to waive the requirement of 180 days of classroom instruction.

In response to this bill, the State Board of Education issued new rules which followed the guidelines above. Also, students' spring semester grades were to be frozen as of March 20, and any remote learning which occurs can only be used to increase the grade. The Board lowered the number of credits required to graduate from 22 to 20, to ensure students were not hurt by the shortened classroom time. Schools may not issue unexcused absences or report truancy for any remote learning not completed. The Board also approved emergency policy changes that will allow student teachers to be approved for licensure, even if they didn't complete all of their required student teaching hours, and will extend educator licenses about to expire until August 2021.

Additionally, Tennessee received approval on its request to the U.S. Department of Education to waive statewide assessment, accountability, and reporting requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 school year.
